AND WHEREAS, the institution, Sahara College of Education, Plot No.: 465/2, 473/10, 11, 473/9/4,471-7, Vill. + P.O. + Teh./Tal. + City: Kalapipal Mandi, Dist.: Shajapur 465337, Madhya Pradesh (WRCAPP3058) has by affidavit consented to come under New Regulations.
